

## ITC conference grant

COST-funded Action TOOLKIT OF CARE (TOC), CA21102 is pleased to announce two (2) Conference Grants for Young researchers and innovators from COST Inclusiveness Target Countries and NNC\*. ITC Conference consists in a presentation of the own work given by a Young Researcher and Innovator affiliated in an Inclusiveness Target Country / Near Neighbour Country for their participation in high-level conferences and workshops fully organized by a third party, i.e. **not organized nor co-organized by the COST Action**.

ITC Conference Grants aim to:

- Serve COST Excellence and Inclusiveness Policy;
- Support Young Researchers and Innovators affiliated in a legal entity in an Inclusiveness Target Countries/ Near Neighbour Countries to establish a strong network and increase their visibility in the research community through sharing their work and to gain knowledge;
- Can contribute to increasing visibility of the Action.

### **Implementation of grant:**

ITC Conference Grantees receive support for attending and presenting their work (poster/oral presentation) at a conference and can establish new contacts for future collaborations.

**Grant amount:** Up to EUR 2 000,00 per grant for face-to-face conferences OR EUR 500.00 for virtual conferences

### **WHO CAN APPLY:**

**ITC Conference Grants are limited to Young researchers and innovators affiliated to legal entities in COST Inclusiveness Target Countries (ITC) and Near Neighbour Countries (NNC).** Applicants are **not** required to be existing members of the COST-funded Action TOOLKIT OF CARE (TOC), CA21102.

COST Association defines the above terms as follows:

Young Researcher and Innovator: A researcher or innovator under the age of 40.

COST Inclusiveness Target Countries (ITC): Bulgaria, Croatia, Cyprus, Czech Republic, Estonia, Greece, Hungary, Latvia, Lithuania, Malta, Poland, Portugal, Romania, Slovakia, Slovenia, Albania, Armenia, Bosnia and Herzegovina, Georgia, Moldova, Montenegro, North Macedonia, Serbia, Turkey, Ukraine (government controlled areas), French Guiana, Guadeloupe, Martinique, Mayotte, Reunion Island and Saint-Martin (France), Azores and Madeira (Portugal), and the Canary Islands (Spain).

COST Near Neighbour Countries: Algeria, Azerbaijan, Belarus, Egypt, the Faroe Islands, Jordan, Kosovo<sup>3</sup>, Lebanon, Libya, Morocco, Palestine<sup>4</sup>, [Russia]<sup>5</sup>, Syria, and Tunisia.

\*Examples of such an affiliation (non-exhaustive list): work contract, enrolment in a PhD or Post-Doctoral programme, voluntary service in a NGO, emeritus professorship, etc

### **Implementation of the Activity:**

Grantee delivers the approved (oral or poster) presentation, following any specific request of acknowledgement set by the Action MC; •

### **HOW TO APPLY:**

Please read carefully the application instructions and ensure all steps of the application process are taken, in order to ensure your application is complete. Incomplete applications will not be considered.

**Submission deadline:** The COST leadership group will consider applications on a bi-monthly basis until successful grants have been allocated.

**Selection criteria:**

- Eligibility of applicant
- Relevance of presentation and conference to COST Action
- Conference must take place before the end of the Grant period

**Reporting and claim for payment of the grant:**

Successful candidates can claim the grant after the conference ends. The required report/documentation for claiming an ITC Conference Grant is:

- Report to the Action MC on the outcome of the presentation of the accepted contribution, in terms of grantee's visibility, including the establishment of new contacts for future collaborations
- The certificate of attendance,
- The programme of the conference or book of abstracts / proceedings indicating the presentation (oral or poster) of the grantee
- Copy of the given presentation (oral or poster);
